3. Civil Law Training

Steve Harris, Board Chairperson, and Jolie Jones, Executive Director, recently attended the Civil Law Training offered to boards and commissions by the Louisiana Department of Justice.

4. Telehealth Registration Process

Board members discussed details of the telehealth registration to assist in setting up the process in the Board's computerized system. Telehealth Registration applicants do not need to upload card for home state licensure or registration, but the Board will require verification to be sent directly to the Board. All telehealth registrants must be queried through the National Practitioner DataBank (NPDB). The Board will remove the question for English being the primary language since the registration is based on licensure in another state for telehealth registrants.

For next year's renewal, we need to add a question to the renewal application for individuals licensed in Louisiana, "do you provide telehealth/telepractice services in Louisiana".

5. LBESPA Presentations

Daphne Washington gave a presentation on May 17, 2018 to 20 speech-language pathology second year students at Louisiana Tech University.

6. Clinical Hours

Board members discussed the need to add a maximum of 25 clinical hours to count for licensure from undergraduate programs to future Rules changes.

7. Legislative Session 2018

Board members reviewed the following:

Act 623 regarding occupational licensing and active supervision and state oversight, Act 693 will allow for sunset review, and Senate Bill 504 requires a response from the Board.

The Board may want to consider adding to the Practice Act that licensees can claim certifications.

COMPLIANCE HEARING:

Taylore Che' 1:30

Taylore Che' requested and appeared for a compliance hearing to appeal the Board's decision to deny the upgrade of her Provisional Speech-Language Pathology Assistant license. The Board denied Ms. Che's request to upgrade her license based on the supervision documentation submitted.

Motion was made by Erica Chatelain, seconded by Deanna Hardy and unanimously carried, to go in to Executive Session at 1:17 p.m. for the following reasons:

to discuss the character, professional competence, or physical or mental health of a person, provided that such person is notified in writing at least twenty-four hours before the meeting, and

for investigative proceedings regarding allegations of misconduct or any other matter now provided for or as may be provided for by the legislature.

Motion was made by Annette Hurley, seconded by Daphne Washington and unanimously carried, to come out of Executive Session at 1:21 p.m. and deny upgrade of Taylore Che's Provisional Speech-Language Pathology Assistant license and offer a Consent Agreement and Order with the following stipulations: successful completion of the Board's open book examination, complete double the required supervision for a Provisional Speech-Language Pathology Assistant license for a period of six months, to include additional on-site in-view and alternative supervision hours. Supervision Form 200s, along with supporting supervision logs, must be submitted on a monthly basis during the six month period, complete 5 hours of continuing education in the area of recordkeeping, in addition to those required for the renewal of her license. Continuing education must be submitted to the Board for pre-approval, and must be completed no later than December 31, 2018. This Consent Agreement and Order is a public reprimand, and shall include publication by LBESPA, Speech Pathologists and

Audiologists in Louisiana Schools (SPALS), the Department of Education, and the National Practitioner DataBank (NPDB).

Motion was made by Deanna Hardy, seconded by Daphne Washington and unanimously carried, to adjourn the meeting at 3:39 p.m.
