The meeting was called to order and the Board's mission statement was read by Glenn Waguespack at 8:35 a.m. in the Conference Room of the Board office located at 37283 Swamp Road, Suite 3B, Prairieville, Louisiana. Jolie Jones, Executive Director was present for the entirety of the meeting. Jerrilyn Frasier participated in the meeting via video conference, as allowed during the state of emergency due to the COVID-19 pandemic. Erica Chatelain was excused from the board meeting.

#### **PUBLIC COMMENTS:**

No one was present at the meeting to provide public comments.

#### AGENDA:

**Motion** was made by Annette Hurley, seconded by Deanna Hardy and unanimously carried, to accept the Agenda as amended to include adding the following to Correspondence: 3. #### MINUTES:

1. Minutes of May 15, 2020

**Motion** was made by Annette Hurley, seconded by Lucie LeDoux and unanimously carried, to adopt the minutes of the meeting held May 15, 2020, as presented.

 Board members were provided a copy of the Financial Statements prepared by Champagne & Company, for the months ended January 2020 – March 2020.

# ENGLISH PROFICIENCY ASSESSMENT 9:15 a.m. ASWATHY ANAKKATHIL PRADEEP

Aswathy Anakkathil Pradeep appeared before the board as required by Rule 113.C. for an English Proficiency Assessment for speakers of English as a second language. Leigh Anne Baker, Speech-Language Pathologist, facilitated the interview via video conference with Ms. Pradeep, requesting oral and written demonstrations of proficiency.

Motion was made by Annette Hurley, seconded by Deanna Hardy and unanimously carried to issue Aswathy Anakkathil Pradeep a conditional Provisional Speech-Language Pathology license once a passing TOEFL score (overall passing, as well as passing for the speaking portion of the exam) is received. The TOEFL exam must be successfully completed within the past two years. Because the essence of the practice of speech-language pathology is communication, the Board suggests improvements with Ms. Pradeep's speech (e.g. accent modification strategies), as well as written expression, including grammar and mechanics. Ms. Pradeep, as well as her supervisor, will be required to submit a report to the Board regarding Ms. Pradeep's ability to be understood by the clients she serves. The Board must pre-approve Ms. Pradeep's supervisor. Reports must be submitted after the first month, then every three months, and must be submitted individually by the both the supervisor and Ms. Pradeep. Ms. Pradeep will be required to appear before the Board for another English Proficiency Assessment before her license can be upgraded.

#### ADMINISTRATIVE REVIEW:

# 1. Continuing Education Concerns

Jolie Jones discussed concerns that she and Erica Chatelain have with some of the continuing education being submitted with audits. Much of the continuing education is obtained from the school system, with many of those hours being related and not directly in the profession. The Board will create an informational flyer about continuing education and will send an email to Special Education/ Speech Coordinators in schools, and ask them to identify if the hours are related or direct hours on the certificates.

#### 2. Executive Director Update

Jolie Jones provided a Directors and Owners insurance policy quote to the Board members to gauge interest. The Board members were very interested and requested two additional quotes to be presented, along with information on what is covered.

**Motion** was made by Deanna Hardy, seconded by Annette Hurley and unanimously carried to waive the Annual School Report requirement for 2020, due to COVID-19. The Board will send out an email stating that the report is waived, reminding Coordinators to ensure that their individuals are licensed to safeguard their students.

**Motion** was made by Annette Hurley, seconded by Deanna Hardy and unanimously carried to authorize the Executive Director to send the annual cease and desist letter to all individuals who have failed to renew their license by August 1, 2020.

# 3. LBESPA Processing

The Board reviewed data for the period of May 7, 2020 – July 17, 2020. The summary is as follows:

Board members requested that conditional licenses be included on the LBESPA Processing data sheet moving forward.

## 4. Update on 2020 Regular and Special Legislative Sessions

Board members reviewed HCR 71 and the report of the Legislative Auditor relative to HCR 71, Act 200, and Act 275. The Board discussed the impacts of each document and will need to review Act 200 in further detail when preparing future rules revisions.

# 5. Provision of Telehealth Services through Declared State of Emergency (Assistants)

The Board discussed the rules relative to the provision of telehealth services by Speech-Language Pathology Assistants during a declared state of emergency. Board members feel that the Board is covered by the Rules and emergency rules are not needed. In the future, the Board will consider a revision to 701.F.1.d.

### 6. Open Book Examination Procedures

Board members discussed how the Board's Open Book Examination is facilitated. Annette Hurley will create a Zoom poll to see how it works. Annette Hurley and Deanna Hardy will review the Ethics portion of the Open Book Examination for needed revisions.

# 7. December Board Meeting Location

Board members would still like to host their December 2020 board meeting in New Orleans.

#### 8. Policies Regarding TOEFL Examination

Motion was made by Lucie LeDoux, seconded by Jerrilyn Frasier and

unanimously carried to create a new policy that the TOEFL passing score must have been obtained within two years. A passing score includes an overall passing score and a passing score in spoken language.

# 9. Online Sale of Hearing Aids

The Board discussed consumer protection concerns relating to companies who are providing online sales of hearing aids. The Board will continue to research this matter and present the findings to the Attorney General's office once completed.

The Rules specify that continuing education hours cannot be split.

Provisional Speech-Language Pathology Assistants in Louisiana must have 100 clinical hours, 75 of which must be direct patient client contact. An individual can also get a Speech-Language Pathology Assistant license with 225 clinical hours.

#### **COMPLIANCE HEARING:**

#### Kelsey Joseph 1:00 p.m.

Ms. Joseph requested and appeared via video conference for a compliance hearing to appeal the Board's decision to deny her application to renew her Speech-Language Pathology Assistant license. The Board denied Ms. Joseph's request to reinstate her license based on the supervision documentation received.

Ms. Joseph provided amended supervision forms and supporting documentation, as well as a letter from her supervisor.

**Motion** was made by Deanna Hardy, seconded by Annette Hurley and unanimously carried, to renew Kelsey Joseph's Speech-Language Pathology Assistant license and

send a letter of concern regarding the names of students listed on the supporting documentation.

#### Dedra Williams 1:15 p.m.

Ms. Williams requested and appeared via video conference for a compliance hearing to appeal the Board's decision to deny her application to renew her Speech-Language Pathology Assistant license. The Board denied Ms. Williams' request to renew her license based on the supervision documentation received.

Ms. Williams provided an explanation to the Board that when she was promised that a supervisor would be assigned to her and after notifying her employer many times, she quit working.

**Motion** was made by Lucie LeDoux, seconded by Annette Hurley and unanimously carried, to offer Ms. Williams a conditional renewal of her Speech-Language Pathology Assistant license, requiring 5 hours of continuing education regarding supervision and/or ethics, in addition to the regular 10 hours required for renewal. Upon proof of completion of the conditional requirements, Ms. Williams must submit a letter to the Board requesting that the conditions be lifted.

#### Elizabeth Bass 1:30 p.m.

Ms. Bass requested and appeared with her supervisor, Michelle Kramer, via video conference for a compliance hearing to appeal the Board's decision to deny her application to renew her Speech-Language Pathology Assistant license. The Board denied Ms. Bass' request to renew her license based on the supervision documentation submitted.

Ms. Bass provided an explanation to the Board that she did not complete supervision every two weeks because of a misinterpretation of the rules. She was employed for 11 hours a week and did not believe that she had to include weeks that she did not work.

**Motion** was made by Lucie LeDoux, seconded by Annette Hurley and unanimously carried, to offer Ms. Bass a conditional renewal of her Speech-Language Pathology Assistant license, requiring double the minimum supervision as a Speech-Language Pathology Assistant for 9 weeks. Upon proof of completion of the supervision, Ms. Bass must submit a letter to the Board requesting that the conditions be lifted.

#### Brionne Jackson 1:45 p.m.

Ms. Jackson requested and appeared via telephone conference for a compliance hearing to appeal the Board's decision to deny her application to renew her Speech-Language Pathology Assistant license. The Board denied Ms. Jackson's request to renew her license based on the supervision documentation submitted.

Ms. Jackson provided amended supervision forms and supporting documentation.

**Motion** was made by Annette Hurley, seconded by Deanna Hardy and unanimously carried, to renew Ms. Jackson's Speech-Language Pathology Assistant license.

# Hannah Francis 2:00 p.m.

Ms. Francis requested and appeared with her supervisor, Crystal Cheatam, via video conference for a compliance hearing to appeal the Board's decision to deny her application to upgrade her Provisional Speech-Language Pathology license. The Board denied Ms. Francis' request to upgrade her license based on the supervision documentation submitted.

Ms. Francis provided an explanation to the Board that she remained under supervision, even though this information was contrary to emails that she submitted to the Board.

**Motion** was made by Jerrilyn Frasier, seconded by Annette Hurley and unanimously carried, to require Ms. Francis and her supervisor to each submit notarized statements, along with supporting therapy logs for further consideration for upgrade of her license.
