EXECUTIVE SESSION:

Motion was made by Lucie LeDoux, seconded by Daphne Washington and unanimously carried, to go into Executive Session at 5:17 p.m. for the following reasons:

COMPLIANCE HEARING:

Tori Hubbard 5:15 p.m.

Ms. Hubbard requested and appeared via video conference for a compliance hearing to appeal the Board's decision to deny her application for reinstatement of a speech-language pathology license. The Board denied Ms. Hubbard's application for license based on belief that Ms. Hubbard practiced without a valid license beginning July 1, 2021 through December 9, 2021.

The Consent Agreement and Order will require successful completion of the Board's open book examination, an additional 15 hours of continuing education, in addition to the 10 regularly required hours by June 30, 2022, and a fine of \$1,500. Such reprimand shall include publication by LBESPA, notification to the Louisiana Department of Education, ASHA, reporting to the National Practitioner DataBank. Notification will also be sent to the International High School of New Orleans and Voices for International Business and Education District.
