## **ADMINISTRATIVE REVIEW:**

### **1. Executive Director Update**

**Motion** was made by Jerrilyn Frasier, seconded by Erica Chatelain and unanimously carried, to purchase a LBESPA sign for the board office monument.

### **2. LBESPA Processing**

### **3. Add Fees to Policy Manual**

**Motion** was made by Erica Chatelain, seconded by Jerrilyn Frasier and unanimously carried, to add fees to the Board's Policy Manual.

### **4. Clarification regarding telehealth during state of emergency**

Board members would like to revise the Rules to state that speech-language pathology assistants may engage in telepractice as directed by their supervisor, provided all supervision guidelines are met.

**Motion** was made by Erica Chatelain, seconded by Jerrilyn Frasier and unanimously carried, to revise the rules before publishing the Notice of Intent to include the provision of service via telehealth for speech-language pathology assistants. Provisional speech-language pathology assistant licensees are prohibited from providing telehealth services. This will not take effect until the Rules are officially promulgated.

### **5. Secretary/Treasurer Position**

Lucie Ledoux has resigned her position as Secretary/Treasurer, as she needs to participate in meetings virtually, as long as allowed.

**Motion** was made by Erica Chatelain, seconded by Daphne Washington and unanimously carried, to appoint Deanna Hardy to serve as Secretary/Treasurer.

## **CONFERENCES:**

### **National Council of State Boards of Examiners (NCSB)**

#### **1. NCSB 2021 Conference, Williamsburg, VA, October 7-9, 2021**

Glenn Waguespack is the only board member who will attend the NCSB conference on behalf of the Board. State information exchange topics include: possible encroachment of dietitians.

#### **2. NCSB Board Member Nominations**

### **Federation of Associations of Regulatory Boards (FARB)**

#### **1. 2022 FARB Forum on Professional Regulation, January 27-29, 2022, Fort Worth, TX**

**Motion** was made by Erica Chatelain, seconded by Annette Hurley and unanimously carried to send Jerrilyn Frasier to the FARB Forum in Fort Worth, Texas, and pay related travel expenses.

## **COMPLIANCE HEARINGS:**

### **Emily Hingle 11:00 a.m.**

Ms. Hingle requested and appeared via video conference for a compliance hearing to appeal the Board's decision to deny her application for a provisional speech-language pathology license. The Board denied Ms. Hingle's application for license based on belief that Ms. Hingle practiced without a valid license beginning August 9, 2021 through September 10, 2021.

**Motion** was made by Daphne Washington, seconded by Jerrilyn Frasier and unanimously carried, to issue a conditional provisional speech-language pathology license and require an extra 3 hours of continuing education in ethics and billing, in addition to the continuing education hours required for the renewal of the license. The Board will also send a letter of concern to Ms. Hingle and her employer.

## **CORRESPONDENCE:**

#### **1. Email from Carolyn Coleman regarding license type**

The Board maintains its position that Ms. Coleman does not meet the current requirements for a speech-language pathology license. The Board will

include its previous letters dated September 24, 2003, June 24, 1996, and October 2, 1997. According to the Board's Rules and Regulations, only those who applied through the grandfathering clause in 1978/1979 were grandfathered in with a bachelor's degree. Since that time frame elapsed, the restricted license has no longer been offered.

**Motion** was made by Daphne Washington, seconded by Jerrilyn Frasier and unanimously carried, to dismiss complaint #2022-04, as the complaint fails to meet the burden of proof.


## 5. Review of Telehealth Applications
