Consent Agreement and Order**Between****The Louisiana Board of Examiners for Speech-Language
Pathology and Audiology****and****Jamie Anderson**

WHEREAS, this matter came before The Louisiana Board of Examiners for Speech-Language Pathology and Audiology (hereinafter referred to as "Board") pursuant to the Application for Licensure received by Ms. Jamie Anderson (hereinafter referred to as "Applicant").

WHEREAS, the information received during the application process reflects that Ms. Anderson practiced Speech-Language Pathology without a valid license from January 2009 through September 2009, in violation of the Louisiana Revised Statutes, Title 37, Chapter 34; Section 2652 and in violation of the Louisiana Administrative Code's Professional and Occupational Standards (Title 46) for Speech Pathology and Audiology, §701(E)(2)(a), §701(E)(2)(b), §701(E)(3)(a), and §701(E)(4)(g).

WHEREAS, the Board is persuaded that it is in the best interest of the public to enter into this Consent Agreement and Order, the conditions of which are set forth hereafter;

WHEREAS, Applicant hereby formally waives any and all legal, administrative, procedural, or judicial remedies, appeals, or relief which might be available under the Administrative Procedure Act, the Speech-Language Pathology and Audiology Act, or any other law or statute;

WHEREAS, the Board and Applicant have entered into this Consent Agreement and Order by which the Board agrees to resolve the licensure concerns. Applicant agrees to accept the following specified conditions in resolution of the concerns.

IT IS HEREBY ORDERED that in consideration of the foregoing and pursuant to the authority vested in the Board, Jamie Anderson will be issued an appropriate license and will be authorized to practice as a Provisional Speech-Language Pathology Assistant, subject to the following terms and conditions:

1. Within ninety (90) days of signing this Consent Agreement and Order, Applicant shall successfully complete an open book examination regarding

Louisiana Revised Statute 37:2650-2666; and Louisiana Administrative Code, Title 46 (Professional and Occupational Standards), Part LXXV (Speech Pathology and Audiology) and Ethical Questions/Situations. License shall be issued upon successful completion of the open book examination.

2. Applicant agrees to a Public Reprimand for violation of the above referenced sections in the Louisiana Revised Statutes; and Professional and Occupational Standards for Speech Pathology and Audiology.
3. Applicant agrees to publication of the violations in the LBESPA newsletter.
4. Applicant agrees to the report of this licensure concern being sent to SPALS, LSHA, ASHA, and HIPDB.
5. The Board will notify Applicant's current and former employers that she practiced without a valid license.
6. Within six (6) months of signing this Consent Agreement and Order, Applicant will complete five (5) hours of continuing education on the subject of ethics and five (5) hours of continuing education on the subject of duties and responsibilities of a speech-language pathologist. The continuing education shall be pre-approved by the Board prior to completing the educational offering.
7. If Applicant fails to successfully and timely complete all requirements set forth above, the Applicant's license shall be **SUSPENDED** without further notice until such time as the Board receives and accepts documentation of Applicant's completion of the requirements set forth above.
