AMENDMENT

WHEREAS, Laura Tircuit is a licensed Provisional Speech-Language Pathologist subject to the jurisdiction and Rules, Regulations and Procedures of the Louisiana Board of Examiners for Speech-Language Pathology and Audiology (hereinafter sometimes referred to as "Board"); and

WHEREAS, in accordance with the Louisiana Speech-Language Pathology and Audiology Practice Act, a Provisional Speech-Language Pathology license can be held for a maximum of three years; and

WHEREAS, January 23, 2011 is the three year anniversary of the issuance of Laura Tircuit's Provisional SLP license; and

WHEREAS, the board believes it should amend Laura Tircuit's Consent Agreement and Order to allow for the timely upgrade of her license; and

WHEREAS, Laura Tircuit agrees to remain under the supervision of a Speech-Language Pathologist until June 30, 2011 and to submit documentation of supervision.

WHEREAS, the Board and Licensee have signed this amendment to Consent Agreement and Order #2011-03.

THIS AMENDMENT is a matter of public record and shall include publication by LBESPA, notification to the Louisiana Speech-Language Hearing Association (LSHA), American Speech-Language-Hearing Association (ASHA), Speech Pathologists and Audiologists in Louisiana Schools (SPALS), the Department of Education, and the Healthcare Integrity and Protection (HIP) Data Bank.
